AGENDA ITEM NO. 1: DELAY IN SCORING OF WORKS

Background:

Contractors are required to submit their work experience details when applying for registration in HEWP. Works are categorized as follows for scoring purposes:

1. Executed through any Department/ Board/ Corporation/ University of Haryana:

These works should be scored by the respective EE (Executive Engineer) of the concerned Department/ Board/ Corporation/ University.

2. Works executed outside Haryana or in the Private sector: These works should be scored by the Nodal EE of PWD/ IRWD/ PHED to whom the registration application has been forwarded by HEWP.

Issue:

Many works in the first category remain unscored by various Departments/ Boards/ Corporations/ Universities for an extended period. This delay is preventing them from availing the EMD exemption benefits.

As of 18/07/2024, the following organizations have 5 or more works pending for scoring for over 30 days:

AGENDA ITEM NO. 2: RESOLVING DEPARTMENT-RELATED TICKETS RAISED ON HEWP

Background:

Tickets raised on the Haryana Engineering Works Portal (HEWP) fall into two main categories:

- 1. Portal Related: These are to be resolved by the IT-Cell of HEWP.
- 2. **Department Related:** These are to be resolved by the concerned Department.

Issue:

The resolution of Department-related tickets is monitored by the Nodal Officer of the respective Department. The following is a department-wise list showing the number of unresolved Department-related tickets as of 18/07/2024.

Action Required:

Review the status of unresolved Department-related tickets and determine necessary actions to expedite their resolution.

AGENDA ITEM NO. 3: CONSTITUTION OF A GUIDANCE TEAM AT THE HEADQUARTERS LEVEL OF DEPARTMENTS / BOARDS/ CORPORATIONS/ UNIVERSITIES ON-BOARDED ON HEWP

Background:

Queries regarding issues faced by various Departments/Boards/Corporations/Universities are received by the IT team of HEWP via telephone and personal visits by concerned officers/officials. Addressing these queries consumes significant IT team resources, reducing availability for portal development and ticket resolution.

Proposal:

1. Constitution of a Guidance Team:

 A team comprising 2 to 3 officers/officials well-versed in HEWP should be formed under the chairmanship of the respective Nodal Officer. This team will provide guidance on queries raised by officers/officials within their organization. Unresolved queries can be escalated to the IT team of HEWP.

2. Training Sessions:

- Despite training videos available on the HEWP homepage, interactive sessions on various modules should be organized for team members after their designation within their respective organizations.
- Interested department officials may register for module training sessions through the "Module Training Request" User Manual, accessible under 'User Manual' (Download >> User Manual) on the HEWP homepage and also under the "What's New" section on the department user login.

Action Required:

Establish the Guidance Team at each organization level to enhance internal support for HEWP users. Organize interactive training sessions as outlined to improve proficiency and support efficiency.

AGENDA ITEM NO. 4: RAISING TICKETS ON THE 'HELP AND SUPPORT' MODULE OF HEWP

Background:

Users may lodge grievances through the 'Help and Support' module of HEWP, via email, or phone. It is essential to adhere to the following guidelines when raising tickets:

1. Mentioning Complete Details with Reference Number:

Every grievance should include the unique reference number assigned to the Tender/DNIT/Estimates. In some cases, these details are omitted, causing programmers to spend unnecessary time searching, leading to ticket resolution delays. Therefore, complete details and reference numbers must be clearly stated in the ticket description.

2. Raising Tickets in Correct Subcategory:

HEWP activities are categorized into various modules. Tickets must be registered under the appropriate subcategory related to the grievance module. Incorrect categorization leads to delays in resolving tickets. It is crucial to raise tickets in the correct subcategory.

3. Mentioning Alternate Phone Number:

The 'Help and Support' module allows users to provide an alternate phone number. This number should belong to a person familiar with the grievance. If the concerned officer is unavailable, programmers can contact this alternate number for clarification, ensuring timely resolution of the ticket.

4. Uploading Screenshots and Relevant Documents:

Users can upload screenshots and relevant documents through the 'Help and Support' module. This facilitates quicker understanding and resolution of the problem by programmers. It is essential to upload necessary documents and screenshots while raising the ticket.

Action Items:

- Emphasize adherence to these guidelines when raising tickets on the 'Help and Support' module.
- Ensure awareness and training on these guidelines for all users of HEWP.

AGENDA ITEM NO. 5: DELAY IN PROCESSING REGISTRATION APPLICATIONS OF CONTRACTORS

Background:

There is a noticeable increase in the backlog of Registration Applications received via HEWP, as concerned offices are not processing these applications within the prescribed time limits defined under the "Registration Rules for Contractors-2022."

Issue:

As of 18/07/2024, the pendency of Registration Applications by department is as follows:

Action Required:

Nodal officers of IRWD, PWD (B&R), and PHED departments are requested to issue directives to all concerned offices for prioritizing the processing of delayed Registration Applications. Progress in this regard will be reviewed during the meeting.

AGENDA ITEM NO. 6: OFFICE/DESIGNATION MAPPING

Background:

HEWP provides a provision to map the Office/Designation within the Organization with the corresponding Engineering offices/designations on the portal.

Issue:

Recently onboarded Government Organizations on HEWP have yet to complete the Office/Designation Mapping activity on the portal.

Action Required:

Government Organizations recently onboarded on HEWP are requested to expedite the completion of Office/Designation Mapping on the portal.

AGENDA ITEM NO. 7: LIMIT OF EXEMPTION OF EMD AS PER CONTRACTOR CLASS

Background:

According to Clause 4 of the Registration Rules for Contractors - 2022, contractors registered on the HEW Portal are eligible for exemption in EMD based on the following criteria:

S. No.	Class of Contractor	Amount of work (for which EMD is exempted)
1.	Class-I	More than Rs.25 crore
2.	Class-II	Upto Rs.25 crore
3.	Class-III	Upto Rs.10 crore
4.	Class-IV	Upto Rs.01 crore

Action Required:

Before granting EMD exemption, verify the name of registered contractors & his score against the Class-wise list available on the homepage of HEWP. This verification ensures that contractors registered in a lower class do not receive EMD exemption for works exceeding the specified limit for their registered class.

AGENDA ITEM NO. 8: DELETION OF FINALLY SAVED ESTIMATES

Background:

The authority to finally save or approve estimates is vested with Nodal-Admins of respective departments, while the authority to delete estimates is as follows:

- 1. Estimates (Not Finally Saved): These can be closed from the login of the concerned Executive Engineer (EE).
- Estimates (Finally Saved/Approved): These can only be closed by the concerned Nodal Officer of the department.

Issue:

Despite this framework, several tickets are being received by the IT-Cell of HEWP related to portal operations requesting closure of estimates. It appears that neither the Nodal Officers nor the field offices are fully aware of this procedure.

Action Required:

Ensure that actions concerning the closure of estimates adhere strictly to the outlined procedures:

- For estimates not finally saved, closure should be managed from the login of the respective Executive Engineer.
- For estimates finally saved or approved, only the concerned Nodal Officer of the department has the authority to initiate closure.

AGENDA ITEM NO. 9: UPDATION OF HRMS FOR REGULAR CADRE EMPLOYEES

Background:

Data for regular employees is imported into HEWP from HRMS (Human Resource Management System). If an employee's data is not updated in HRMS, they are unable to

perform activities in HEWP. Updates made in HRMS are reflected in HEWP the following day.

Issue:

Tickets are being received in HEWP requesting updates for employee data due to lack of awareness. However, such updates should be managed within the HRMS by the concerned organization. Updated data automatically reflects in HEWP the next day.

Action Required:

All organizations utilizing HRMS are urged to ensure timely updates of employee data within their HRMS systems. Employee data can be verified in the 'Employee Directory' on the homepage of HEWP.

AGENDA ITEM NO. 10: IMPLEMENTATION OF HRMS IN ALL DEPARTMENTS/BOARDS/ CORPORATIONS/ UNIVERSITIES

Background:

HEWP has been integrated with HRMS to import data of regular employees. However, some Boards/Corporations have not adopted HRMS, and instead, have manually entered their employees' data into HEWP. This creates issues for updating data during transfers, promotions, extended leaves, etc. Additionally, many government officers are deputed to these organizations, and their data is in HRMS but cannot be imported due to the lack of HRMS implementation..

Issues:

- Incomplete or inaccurate data updates for employees in non-HRMS using organizations.
- 2. Difficulty in integrating data of deputed government officers into HEWP due to the absence of HRMS.

Action Required:

Organizations not currently using HRMS need to implement HRMS to:

- Ensure accurate and timely updates for employee data.
- Facilitate integration of government officers' data from HRMS into HEWP.

AGENDA ITEM NO. 11: PERSUASION OF CONTRACTORS FOR DEPOSITING SECURITY

Background: Security (refundable One Time Deposit - OTD) is required from contractors to complete the registration process. However, it has been observed that contractors often delay depositing this amount. Details are provided in **Annexure 'B'**.

Issue: Contractors are frequently late in depositing the required security amount, hindering timely completion of registration processes.

Action Required: Departments where these contractors are engaged should actively pursue them to deposit the security amount promptly.

AGENDA ITEM NO. 12: IDENTIFICATION OF MASTER TRAINERS IN VARIOUS DEPARTMENTS/BOARDS/CORPORATIONS/UNIVERSITIES

Background: It is necessary for each Organization to identify master trainers who will receive training from the HEWP team. These master trainers will then impart training to field functionaries and other staff within their respective Organization.

Action Required: Organizations are required to identify suitable individuals as master trainers. These individuals will undergo training facilitated by the HEWP team to enable them to effectively train other staff members. The names of such Master – Trainers may be brought in the meeting.

AGENDA ITEM NO. 13: PROPOSED CHANGES IN COMMON BID DOCUMENT (CBD)

Background: A meeting was held on 19.04.2024 at 03:30 PM under the Chairmanship of the Engineer-in-Chief (Roads), PWD (B&R), in the Main Committee Room, NirmanSadan, Plot No.1, Sector-33/A, Chandigarh. The meeting discussed proposed changes to the Common Bid Document (CBD).

Discussion: The proposed changes to the Common Bid Document (CBD), as detailed in Annexure 'C', were discussed during the meeting. Following the discussion, a letter was submitted to the Haryana Public Works Department (B&R), Chandigarh, for necessary action. The letter was submitted vide memo no. 44828-PHE/HEWP dated 14.05.2024.

Action Required: Review and take necessary action on the proposed changes to the Common Bid Document (CBD) as discussed and submitted.

AGENDA ITEM NO. 14: PERFORMANCE BANK GUARANTEE

Background: Some contractors have been debarred for not depositing the Performance Bank Guarantee (PBG) within the stipulated time after the issuance of the "Letter of Acceptance". A new provision now allows contractors to submit an appeal from their login on HEWP with proof of PBG deposit.

New Procedure: Contractors can submit an appeal online through their HEWP login, providing proof of PBG deposit. Once the appeal is submitted, it will be visible to the concerned Executive Engineer (EE) in their login. The EE can then review the records and accept the appeal. Upon acceptance, the contractor's debarment will be revoked.

Action Required: Nodal Officers are requested to inform all relevant EEs and contractors about this new provision and the process for submitting and handling appeals.

AGENDA ITEM NO. 15: CHANGE OF NODAL OFFICER

Background: It is crucial for efficient coordination within HEWP that changes in Nodal Officers are promptly communicated. This ensures continuity and effective management of responsibilities.

Procedure for Notification: In case of any change in the Nodal Officer, please follow these steps for timely notification:

- 1. Send a scanned copy of the notification letter to Project Engineer, HEWP via email at pankaj.kamboj-p-hry@phedharyana.gov.in.
- 2. Alternatively, submit the notification letter to the Project Director HEWP cum Chief Engineer (Mech.), PHED Head Office, Bay No. 13-18, Sector 4, Panchkula.

Item No. 7: Limit of Exemption of EMD as per Contractor Class:

Before granting EMD exemptions, the concerned officer must verify the contractor's name and score against the Class-wise list available on the HEWP 'Home Page'. This verification is crucial to ensure that contractors registered in a lower class do not receive EMD exemption for projects exceeding the limits specified for their class.

The concerned officer must also verify before granting the EMD exemption that the contractor has attached the EMD declaration form downloaded for the specific tender for which the exemption is sought. If the declaration form is not uploaded for the respective tender, the exemption will not be valid.

The Nodal Officers HEWP need to sensitize the field officers in this regard.

Item No. 8: Deletion of Finally Saved Estimates:

The estimates can be deleted from HEWP by adopting the following procedure:

Estimates Not Finally Saved: The authority to close these estimates is already with the concerned Executive Engineer, who should perform the closure from their login.

Estimates Finally Saved or Approved: Closure of these estimates is within the authority of the concerned Nodal Officer HEWP of the Department/ Organization.

Item No. 9: Updation of HRMS for Regular Cadre Employees:

It was emphasized that all Departments/Organizations utilizing the HRMS must ensure the timely update of employee data within their HRMS systems. This is crucial as any delay in updating employee data in HRMS affects the functionality of HEWP, where the data is reflected the following day.

However, Tickets are being received in HEWP due to the lack of awareness regarding this procedure. The Nodal Officers HEWP may ensure that such updates should be managed within HRMS by the respective Department/ Organization.

Item No. 10: Implementation of HRMS in all Departments/ Boards/ Corporations/ Universities:

It was emphasized that the Organizations not currently using HRMS are required to implement HRMS to:

- 1. Ensure accurate and timely updates for employee data.
- 2. Facilitate the integration of government officers' data from HRMS into HEWP.

The Nodal Officers HEWP may follow up with the concerned field officers, where these contractors are working, to pursue with respective contractors to deposit the OTD.

Item No. 12: Identification of Master Trainers in various Departments/ Boards/ Corporations/ Universities:

The Master Trainers are required to be identified from the respective Department/ Organization to receive training from the HEWP Team, equipping them to effectively train other staff members within their Organization. The Nodal Officers HEWP may take up this matter with the respective Department/Organization and send the name of these Master Trainers to the Project Director HEWP so that the training may be arranged.

A proposal for changes in the Common Bid Document (CBD) has been submitted to the Haryana Public Works Department (B&R), Chandigarh, for necessary action vide memo no. 44828-PHE/ HEWP dated 14.05.2024. The approval of the proposal is awaited from PWD (B&R).

(Action to be taken by:- PWD (B&R))

Item No. 14: Debarring of contractors due to non submission of Performance Bank Guarantee (PBG):

A new provision has been created on HEWP, for the contractors debarred due to non submission of PBG within stipulated time, allowing contractors to submit an appeal through their HEWP login, alongwith proof of PBG deposit. Under the new procedure, contractors can submit their appeal online via their HEWP login, including proof of PBG deposit. Once submitted, the appeal will be visible to the concerned Executive Engineer in their login. The Executive Engineer will review the records and, if appropriate, accept the appeal. Upon acceptance, the contractor's debarment will be revoked.

The Nodal Officers HEWP may sensitize the various field officers and contractors in this regard.

Item No. 15: Change of Nodal Officer:

To ensure effective management and continuity, any change of Nodal Officer HEWP should be promptly communicated through Email at info-hewp.pwd@hry.gov.in.

Item No. 16: Challenges/ Issues:

The Nodal Officers HEWP were asked to share any challenges or issues they are facing with the HEW Portal.

The following issues were raised by the Nodal Officer HEWP Urban Local Bodies Department:

- User credentials for Commissioner of Municipal Corporation (CMC) and District Municipal Commissioner (DMC) need to be created.
- 2. The provision should be made for scoring contractors work before closing the agreement.
