Since its inception in May 2021, 46 Government Departments, Boards, Corporations and Universities (**Annexure 'A'**) have been on-boarded on HEWP. The other latest key statistics of HEWP are enclosed at **Annexure 'B'**.

Agenda item No. 1/2. SQL server license procurement status

8 SQL Server 2019 Enterprises Edition & 2 SQL Server 2019 Standard Edition Licenses for HEWP was required for better management of HEWP database. Therefore, the same are being procured through GeM. Work order has been placed for delivery of latest version of 8 SQL Server Enterprises Edition & 2 SQL Server Standard Edition on GeM and are expected to deliver before 29.12.2023.

Agenda item No. 1/3. Opening of bank account of HEWP

The directions of Hon'ble CM Haryana were conveyed vide Diary No. 17224 dated 11/04/2022 (Annexure 'C') that e-service fee collected per bid on the NIC e-Tendering portal and currently being transferred to the 'Society for IT Initiative funds for e-Governance' shall henceforth be transferred to a designated account of the HEWP. The concurrence of the Finance Department for opening an Escrow account of HEWP in the name of Engineer-in-Chief PHE Department was also conveyed vide U.O. No. IFCC/ 2022/ 13395 dated 01/09/2022 (Annexure 'D'). Subsequently, a meeting was held with the Director General, Supplies and Disposals Haryana on 28/10/2022 in the matter. The minutes of the meeting were sent to the Director General, Supplies and Disposals, Haryana vide Memo No. 97800-03-PHE/B-3 dated 15/11/2022 (Annexure 'E') who sought clarifications in the matter vide Memo No. DSD/ Admn/ NIC Portal/ 2022-23/ 9964 dated 03/01/2023 (Annexure 'F'). The reply to the clarification were sent vide Memo No. 13450/ HEWP dated 07/02/2023 (Annexure 'G'). The further action in the matter is awaited from the O/o the Director General, Supplies and Disposals Haryana. This is for the information of the members of the Steering Committee of PMU of HEWP please.

Agenda item No. 1/4. NIC e-Tendering integration issue

NIC has provided their advanced API for better integration with HEWP, the document signer certificate for the same has been procured and testing of the said integration is in-process and likely to be completed in one week. Further, a proposal for Inviting Expression of Interest for selection of Banking Partner to provide integrated IT solution for e-Tendering of Engineering works on HEWP has also been submitted to Govt. vide CFMS No. 3805 dated 12/06/2023 (Annexure - H).

Agenda item No. 1/5. Bank integration with HEWP

Bank of Baroda has been integrated with HEWP for payment of contractor bills wherever required. As of now, HSAMB is processing their contractor bills through Bank of Baroda. The payment amounting to Rs.122 crores has so far been made by HSAMB through said Bank on HEWP. The process for Integration with another bank namely IndusInd Bank for the Development & Panchayat Department is at an initial stage.

Agenda item No. 1/6. Registration-cum-Enlistment Rules for Contractors

The draft Registration-cum-Enlistment rules for Contractors-2023 were prepared by PWD (B&R) and submitted for approval from Government. The Finance Department sought clarification in the matter vide U.O. No. 17/01/2020-3FICW/11933 dated 03/08/2023 (**Annexure 'I'**). The reply to the same has been submitted by PWD (B&R). The approval of the rules is awaited from Government.

Agenda item No. 1/7. Staff position of PMU HEWP

The creation of PMU for taking policy level decision and strategic implementation of HEWP with the involvement of various stakeholder Departments, Boards, Corporations and Universities was approved by Hon'ble CM Haryana vide File Receipt No. 8769 dated 20/22/02/2023 (Annexure 'J'). The PMU consists of an 'Apex Committee' with Hon'ble Chief Minister Haryana as its Chairperson, PSCM as Vice Chairperson and Additional Chief Secretary PHE Department as its Member Secretary, a 'Steering Committee' with Additional Secretary PHE Department as its Chairperson and Project Director HEWP as its Member Secretary and an 'Executive Committee' with Project Director HEWP as its Chairperson and Project Engineer HEWP as its Member Secretary. The PMU setup (Hierarchy and Human Resources) is covered under Clause 4 (Annexure 'K') of the PMU document.

Agenda item No. 1/8. Redressal of grievances on HEWP

The Grievances related to the operation of Haryana Engineering Works Portal can be raised by the on-boarded Contractors & Govt. Organizations are received through following means :

The grievances registered through tickets are forwarded to Department concerned/ IT Team of HEW Portal for timely action and rectification. The status of the grievances is periodically tracked and updated. The complainant may know the status of the grievances registered by contacting the Call Center personnel or through Web Portal.

A Call Center in the matter is presently being operated through HARTRON from Monday to Saturday. However, to address the grievances related to operation of Haryana Engineering Works Portal on a proactive basis and provide effective, assured and timely services to the on-boarded Organizations and Contractors across the Haryana State, a new Call Center, with high skill call support staff, is to be set up in the premises of Public Health Engineering Department which will work in one shift from Monday to Saturday. The tenders for the said Call Center have been opened on 08/12/2023 and further action in the matter is under process. This is for the information of the members of the Steering Committee of PMU of HEWP please.

Agenda item No. 1/9. Allotment of tenders in offline mode

The instructions were issued vide Memo No. 107438-7460/HEWP dated 13/12/2022 (Annexure 'L') that the allotment of Tenders for all the Engineering works floated through HEWP may only be done through said Portal. The Finance Department was also instructed vide worthy PSCM office note dated 23/12/2022 (Annexure 'M') not to release payment for Engineering Works where allotment of works or post allotment actions are carried out through the offline mode. However, it has been observed that some State Govt. Organizations are using HEWP for preparing estimates, DNIT and Tenders for Engineering Works but allotment and post allotment activities are being carried out in offline mode. Out of 48689 Tenders floated on HEWP so far, only 25200 have been allotted on the Portal.

An analysis of the Tenders costing Rs. 5 Crore and above floated on HEW Portal with Bid opening date from 01/01/2023 to 30/06/2023 was done so as to ascertain the allotment done against these Tenders and out of these 288 tenders, only 131 have been allotted on HEWP upto 30/11/2023 as per the list enclosed at **Annexure 'N'**.

The concerned Govt. Organizations need to ensure that the allotment and post allotment activities may be done on HEW Portal.

Agenda item No. 1/10. Revision of Haryana Schedule of Rates

A meeting was held under the Chairmanship of Additional Chief Secretary to Govt. Haryana PHE Department on 05/06/2023 where the matter for the revision of Haryana Schedule of Rates was taken up. The Record of Discussion of said meeting was sent to Hon'ble CM Haryana on which it was desired by the Hon'ble CM that the HSR Revision is to be under taken every 2 years instead of every 3 years starting with 2024. The Engineer-in-Chief Haryana PWD (B&R) and the Engineer-in-Chief Haryana Irrigation & Water Resources Department were requested vide Memo No. 60666-67/HEWP dated 30/06/2023 (Annexure 'O') to take necessary action in the matter.

The report about the action taken in the matter is awaited from PWD (B&R)

Agenda item No. 1/11. Offline preparation of bills of the works allotted on HEW Portal

Out of 25200 works allotted on HEWP, only 8084 have been processed for e-billing on HEWP. The Department wise list showing the number of works allotted and the works for which E-MB and billing has been done on HEWP is placed at **Annexure** 'P'. Most of the Departments have not gone for E-MB and billing on HEWP.



The parawise reply to the clarifications asked vide the memo under reference is as follows :

(a) The need to develop Haryana Engineering Works Portal (HEWP) is explained below :

Hon'ble CM Haryana made some Announcements during the meeting with Civil Engineering Contractors held on 20.01.2021. The Announcement Code 25487 (Annexure 'A') made by Hon'ble CM on 20/01/2021 is reproduced below :

"Complete State Level IT Solution will be implemented for all engineering works starting from registration of contractors preparation of DNIT, e-tendering, transparent IT based technical evaluation, online allotment of work contract, e-Measurement Book to be filled in first by contractor, time bound passing of contractor's bills and online payments. This will be implemented from 1st April 2021".

Thus Complete State level IT solution was required to be implemented for all engineering works starting from registration of contractors upto the time bound passing of contractor's bills and online payments as per details given in said CM Announcement. Accordingly, Haryana Engineering Works Portal (HEWP) was developed for better and effective monitoring of works carried out in the State through various Departments, Boards and Corporations. NIC e-Procurement Portal, on the other hand, serves only the limited part of the above explained process from 'Online Tendering of works' up to the 'Award of works'.

(b) The necessity for integration of HEWP with NIC e-Procurement portal is explained below :

As part of the CM Announcement stated in the preceding paragraph, HEWP integration with NIC e-Procurement Portal is essentially required for pushing the information pertaining to tenders from HEWP to NIC e-Tendering and vice-versa for better tracking of tenders. Another Announcement Code 25493 (Annexure 'B') made by Hon'ble CM Haryana on 20/01/2021 in the matter is also reproduced below :

"In case of all works beyond Rs. 1.00 Crore, the report of technical evaluation

will be placed on the website for any interested person to submit their objection within 7 days. In case any objection is received, then further action will be taken only after the objection is disposed. The time period for disposal of objections will be two weeks".

As per the above CM Announcement and subsequent meetings held in the matter, technical evaluation of tenders of more than Rs. 1 Cr (now changed to Rs. 64 Lakhs) has to be carried out online and published on HEWP for contractors to raise an objection, if any, within 7 days of publishing the result of technical evaluation carried out by the officers randomly selected by the system. Multiple VCs have also been conducted with NIC Delhi and NIC Chennai under the Chairmanship of Worthy PSCM for integration of HEWP with e-Procurement portal for e-Tendering process.

(c) The reply to be this clarification has already been given at (a) and (b) above.

Subject :- Inviting Expression of Interest for selection of Banking Partner to provide Integrated IT solution for e-tendering of Engineering works on Haryana Engineering Works Portal.

As per CM Announcement Code 25487 dated 20/01/2021 (F/A), a complete State level IT solution has been developed to cater Contractor Registration & their Work Assessment and all the Civil Engineering needs of executing Departments/Boards/Corporations starting from electronic Estimate preparation, Detailed-Notice-Inviting-Tender Sanction, Administrative Approval, Technical (DNIT).electronic Common Bid Document, e-Tendering, Online Technical Evaluation of Bids, Objections resolution, Negotiation & Allotment of work, electronic Measurement Book, electronic Billing to Final Bill payment of the work. To build an end-to-end solution various API Integrations have been done with different applications like Haryana HRMS, PPP, HUM, NIC e-Tendering etc. As part of e-Tendering module an integration with NIC e-Tendering Portal (GePNIC) was done, for publishing of tenders on e-Tendering portal floated through HEWP. The integration done with NIC e-Tendering portal have some limitations on part of data sharing with HEWP due to NIC own constraints. As of now, the following API integration mechanism is available in between NIC e-Tendering portal and HEWP: -

- I. NIC e-Tendering portal only accepts the metadata of tender from HEWP and then the concerned Tender Inviting Authority has to upload DNIT & BoQ on e-Tendering portal to publish the same.
- II. Only after the Award of Contract to the contractor on NIC e-Tendering portal; the metadata information about the same is received on HEWP. Moreover, the Technical Evaluation is done on HEWP by manually entering the information of participated contractors/bidders; whereas the bidder has placed their bid on e-Tendering portal. Furthermore, the Financial comparative summary generated on e-Tendering portal is uploaded on HEWP for negotiation and allotment of work.
- III. Any Corrigendum issues on e-Tendering portal, the metadata of the same information is received on HEWP for corrective measures on HEWP.

As there are lot of manual activities being done by the officials despite of integration with NIC e-Tendering; therefore, there is a need of an automotive API integration process in which e-Tendering system shall not only accept metadata but also accepts DNIT, BoQ & additional documents pertaining to tender from HEWP.

Several grievances are being received from the Development & Panchayat Department and various Urban Local Bodies due to errors occurring during the manual activities required to be done as explained above. The rectification of these errors consume a lot of time thus resulting in delay in allotment of works and their subsequent execution.

Further, after opening of the tender, the information pertaining to the participated bidders along with documents shall be shared with HEWP through API for Technical evaluation to be carried out on HEWP. Moreover, the financial comparative summary shall be shared with HEWP through API for negotiation and allotment of work

The above automotive API integration process has many times been conveyed to NIC e-Tendering Team through various VCs and emails but due to their own constraints they are not allowed to share the data in-between of tendering process. Due to the limited integration of NIC e-Tendering portal with HEW Portal, difficulties are being faced in processing of tenders resulting in delay in allotment of tenders.

A meeting was held under the Chairmanship of worthy PSCM Haryana on 02/05/2023 in which the above matter was discussed. The worthy PSCM intimated that Haryana Mines and Geology Department conducts e-auction of mines of mineral deposits with the involvement of Banking Partner and that e-auction in some other Govt. Department is also being conducted with the involvement of Banking Partner. It was desired by him that the proposal for e-Tendering for Engineering works on HEWP with the involvement of Banking Partner be put up.



The Govt. intimated vide memo no 4/16/2021-RU dated 17/05/2021 (F/A) that Hon'ble Chief Minister has approved the Interdepartmental Project Management Unit (PMU) for implementation of the Unified Portal for Engineering Works as per the details given in said letter and requested to take necessary action in the matter accordingly.

The Haryana Engineering Works Portal (HEWP) was subsequently launched by Hon'ble Chief Minister on 24/05/2021. HEWP has been developed as a complete end-to-end solution to cater Contractor Registration & their Work Assessment and all the Engineering needs from electronic Estimate preparation to Final Bill payment of the Engineering works being done across various Departments/Boards/Corporations in Haryana. The Portal has been designed, developed and maintained by the core team of PHED, PWD (B&R) and IWRD.

There is necessity to keep the portal live in terms of regular development updates and maintenance. The portal is being used by 28 onboarded Departments/ Boards/Corporations (list placed at F/B). Further, for effective utilization of HEWP, there is need to establish Project Management Unit (PMU) for taking policy level decisions and strategic implementation of the Portal with the involvement of various stakeholder Departments, Boards and Corporations. The following three Committees have been proposed for PMU :-



Ref: PSCM note dated 19/05/2023 (F/A) stating that:-

"CM has directed that the Committee of Engineers-in-Chief working with the PMU for the Haryana Engineering Works Portal may immediately take up the task for the revision of the Haryana Schedule of Rates through the direction committees that have been established for the purpose. CM would like to status on the same by 30th June, 2023".

In this regard, a meeting of PMU comprising of Engineer-in-Chief of PWD(B&R), Public Health Engineering Department and Irrigation & Water Resource Department was convened on 26/05/2023 to consider the revision of Haryana Schedule of Rates(HSR).

The following observation was made by the undersigned in the meeting :

"During detailed discussion there was a consensus that DSR be examined as it is more exhaustive as has more schedule items thus leaving lesser NS items in a typical WTP, STP, Building, Roads, Bridges tender/ estimates. The EICs present also pointed out that DSR is 15-20% above HSR in general. To see the actual difference in the two Rates Schedules, it was decided that an existing building (say a Sectt. of District/ Sub-Division), a CHC, ROB or a bridge of span > 100 m, a 4-lane road estimate be made as per DSR and then be compared to the HSR estimate already prepared. The comparison be made for both schedule & Non-Schedule in total amounts tabulation. The meeting shall be held again on 05/06/2023 at the same time & venue".

Subsequent meeting was held, under the chairmanship of the undersigned, as decided above, on 05/06/2023 and was attended by the following :

On the basis of above analysis, it can be clearly observed that:

- (A) The estimates prepared on the basis of DSR are *much higher* than the estimates prepared on the basis of HSR.
- (B) Many HSR items are not to be found in DSR. The HSR items rates have been taken for such items (which are not available in DSR) for comparison purposes.

In view of above observations, total adoption of DSR, in place of HSR, for implementation in Haryana is not desirable as it would lead to much higher cost of works and create difficulties as many of the HSR items are not available in DSR. Thus, the proposal to implement DSR in Haryana was not found suitable at all and summarily dropped.

It was decided to formulate the action plan for regularly updating the recently revised and issued HSR-2021. The frequency of up-dation of CPWDs' DSR was also deliberated upon and it was found that the DSR has been updated *thirteen (13) times over the past 46 years i.e. once* every 3.5 years or so by CPWD. As informed by PWD(B&R) officers, this is owing to the fact that there is a full Technical cell in CPWD, headed by an ADG level officer, dedicated to this purpose - It is not so in Haryana PWD.

Accordingly, it was resolved as follows :-

- (i) HSR shall be updated after every three (03) years;
- (ii) NS items, which get uploaded in the now well-established HEW Portal (over 20,000 tenders floated), shall be included in HSR as a scheduled item once in a year, preferably w.e.f April of every year. The Zonal Committees, already formed, shall hold regular meetings to decide such NS items.

30

- (iii) If (i) above is approved, then, EiC/PWD(B&R) shall repeat the exercise every three (03) years. The procedure followed for updation of HSR-1988 to HSR-2021, including hiring of consultants, should now again be followed so as to complete the revision of HSR-2021 in a time-bound manner i.e. by March 2024 as per (i) above. Engineer-in-Chief, Haryana PWD(B&R) shall separately take requisite approval from Govt. in this regard immediately and repeat every three (03) years.
- (iv) NS items shall be minimized for common works such as new CHCs, PHCs, Health Centre, New Tchsil, New Sub-Tehsil, Police station buildings etc. etc. i.e. all the generic buildings which have standard drawings/layout.
- (v) Wherever branded items are to be used, minimum five brands be specified. These items may be classified as 'Premium' and 'General'. The 'Premium' items may be used in District level HOD, State Head Quarter and other higher offices and in any other building with the prior permission of competent authority.
- (vi) New Construction material/ technology must be included while revising the HSR and is done in DSR.
- (vii) The legacy items in the HSR- 2021 may be removed while preparing the new HSR wherever they are now considered/deemed obsolete.
- (viii) Deliberation will be held with UHBVN, DHBVN, HVPNL etc. for including the electrical items in the new HSR so that a comprehensive document is made for the benefit of all departments, agencies and all related/interested parties as also in the public interest.

Organizations. The Chairman directed that the instructions issued vide worthy PSCM note dated 23/12/2022 regarding undertaking allotment and post allotment activities on HEWP, be complied by all the Organizations on-boarded on HEWP.

Other points discussed with the permission of the Chair:-

The Nodal Officer HEWP, Development & Panchayat Department raised the following issues :

- Tenders are floated by the Engineering wing but the payment is made by PRI in the Development & Panchayats Department and therefore PRI representatives need to be on-boarded on HEW Portal for making the payments. The Nodal Officer was informed that the E-MB and Billing may be done on HEWP and approval regarding the exemption of payment on HEWP by the PRI may be taken from Govt.
- 2. Approval has been granted by the Finance Department for the Integration of IndusInd Bank with HEWP for payment of contractor bills. The process for integration of the IndusInd Bank may be completed at the earliest. The Nodal officer was informed that this point has already been covered in Agenda Item No. 1/5.
- 3. The Bank Account of Haryana Grameen Vikas Yojana under the Rural Development Department is being maintained in HDFC Bank which is required to be integrated with HEWP. It was decided that Rural Development Department may seek approval from the Finance Department for the integration of HDFC Bank with HEWP for payment of the Contractor Bill for this scheme.
